

**MEYOCKS DESERVING TEACHER CONTEST  
AMENDED OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. SPONSOR:** The Meyocks Group, Inc., 6800 Lake Dr. #150, West Des Moines, IA 50266.

**2. CONTEST PERIOD:** The Meyocks Deserving Teacher Contest (the “Contest”) begins on July 18, 2019 at 5:00:01 p.m. Central Daylight Time (“CDT”) and ends on August 22, 2019 at 11:59:59 p.m. CDT (the “Contest Period”). The nomination period begins on July 18, 2019 at 5:00:01 p.m. CDT and ends on August 5, 2019 at 11:59:59 p.m. CDT (the “Nomination Period”).

**2. CONTEST ELIGIBILITY:** The Contest is open to legal residents of Iowa, Illinois, Minnesota, South Dakota, Nebraska, Kansas, Missouri, and Wisconsin who wish to nominate (“Nominators”) a K-12 classroom teacher from any public or private school in Iowa, Illinois, Minnesota, South Dakota, Nebraska, Kansas, Missouri, and Wisconsin (“Nominees”). Nominees must be at least eighteen (18) years old at the time of the Nomination. Nominators and Nominees must be able to travel to Lakeville, Minnesota on August 22, 2019 at their own cost and expense if they are selected as the winners. Employees of The Meyocks Group, Inc. (“Meyocks”) and those companies, entities and individuals involved in the development, fulfillment or production of this Contest (collectively, “Contest Parties”), and their respective parents and/or affiliate companies, as well as immediate family members (spouse, parents, siblings, children, grandparents and/or “step”) and household members of each such employee, are not eligible to be Nominees. The Contest is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes Nominators full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Contest. Winning a Prize is contingent upon Nominees fulfilling all requirements set forth herein. In the event of a conflict between the entry instructions on any entry form and these Official Rules, these Official Rules shall control.

**4. TO ENTER:** To enter the Contest, during the Nomination Period, Nominators may nominate a Nominee by submitting a nomination to [teachernominations@meyocks.com](mailto:teachernominations@meyocks.com) or Meyocks, 6800 Lake Dr. #150, West Des Moines, IA 50266 (each, a “Nomination”). Each Nomination must include (i) the Nominator’s name and email address; (ii) the Nominee’s name and school (with postal address, email address, or phone number), (iii) the subject and grade that the Nominee teaches; and (iv) a brief description of the Nominee and what makes him/her deserving of recognition, including information regarding the Nominee spending his/her own money on supplies for students. Nominators under the age of 18 must also provide a parent’s or legal guardian’s information in the Nomination, and must review these Official Rules with their parent/guardian. All Entries must be submitted or postmarked during the Nomination Period to be considered a valid Nomination.

Nominator may be asked to provide more information for Sponsor to confirm identity and eligibility of Nominee, and may be asked to submit to a background check.

There is a limit of one (1) Nomination per Nominator per Nominee during the Nomination Period.

**5. SELECTION OF WINNERS AND PRIZES:** During the Contest Period, a committee selected by Sponsor (“Selection Committee”) will select four (4) Nominees (“Prize Winner(s)”), in its sole discretion, from all eligible Nominations that best meet the criteria set forth above. Each Prize Winner will win a gift card equal to \$599.99 to a store of Sponsor’s choice (approximate retail value for each Prize: \$599.99; approximate retail value for all Prizes: \$2,399.96) (“Prize”). Each Prize Winner’s Nominator will win a \$100.00 gift card to a store of Sponsor’s choice (approximate retail value for each Prize: \$100.00; approximate retail value for all Prizes: \$400.00) (“Prize”).

The winning Nominators will be notified by telephone or email following selection. The winning Nominators and Prize Winners must be available to accept their Prizes at a location within the Twin Cities, Minnesota area on August 22, 2019, at a time determined by Sponsor. If a winning Nominator and/or Prize Winner is unable to accept the Prize

as stated, an alternate winner may be chosen. All federal, state, and local tax liabilities are the sole responsibility of the Prize Winner. The winning Nominators and the Prize Winners will be required to complete and return an Affidavit of Eligibility and Publicity/Liability release form. The Prize Winners may be required to complete and return an IRS W-9 form (*i.e.*, Request for Taxpayer Identification Number and Certification). Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion.

**6. RELEASE / INDEMNIFICATION:** By participating in the Contest and/or accepting a Prize, Nominator (or Nominator's parent or legal guardian, if Nominator is a minor) and Prize Winner agree to release, discharge, indemnify and hold harmless the Contest Parties and each of their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, employees, representatives and agents (collectively, the "Released Parties") from and against any claims made by Nominator (or Nominator's parent or legal guardian, if Nominator is a minor), Prize Winner, or any other third parties related in any way to the operation of the Contest, as well as any other claims, damages or liability due to any injuries, damages or losses (whether alleged, threatened, or actual) to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any Prize or participation in any Contest-related activity or participation in the Contest.

**7. PUBLICITY:** Except where prohibited, participation in the Contest constitutes the consent of each Nominator and Prize Winner to the Contest Parties and their respective agents' use of Nominator's and Prize Winner's name, age, photograph, voice, likeness and/or image, and hometown address for promotional purposes in any media, worldwide, without further payment or consideration.

**8. GENERAL CONDITIONS:** Sponsor reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Contest, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the Entry process or the operation of the Contest or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

**9. LIMITATIONS OF LIABILITY:** The Released Parties are not responsible for any problems that may arise, including but not limited to: (a) Nominations that are late, lost, illegible, mechanically reproduced, contain false information, damaged, misdirected, mutilated, garbled or incomplete, altered or otherwise irregular, that have been submitted using robotic, programmed, script or any other automated means, or illicit means, or do not conform with or satisfy any or all of the conditions set out in the Official Rules, as determined by Sponsor in its sole and absolute discretion; (b) postal delays, strikes or failures; (c) communications failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions or hardware or software malfunctions, failures or difficulties; (d) for any other errors of any kind, omissions, incorrect or inaccurate information relating to or in connection with the any Contest-related materials or the Contest, whether human, mechanical, clerical, electronic, or technical in nature; (e) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the Contest; or (f) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Nominator's or Prize Winner's participation in the Contest or receipt or use or misuse of any Prize. If the Contest, or any part of it, is discontinued for any reason, Sponsor, in its sole discretion, may elect to choose a winner by judging all eligible Nominations received up to the date of discontinuance for the prize offered herein.

**10. GOVERNING LAW/DISPUTES:** This Contest is governed by the laws of the United States and the State of Iowa. As a condition of participating in this Contest and/or accepting a prize, each Nominator and Prize Winner agrees, to the extent permitted by law, that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or in connection with this Contest, will be resolved individually, without resort to any form of class action, exclusively before a court located in the State of Iowa. FURTHER, IN ANY DISPUTE, UNDER

NO CIRCUMSTANCES WILL YOU BE PERMITTED TO OBTAIN AWARDS FOR, AND YOU HEREBY WAIVE ALL RIGHTS TO CLAIM, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING ATTORNEYS' FEES, OTHER THAN YOUR ACTUAL OUT-OF-POCKET EXPENSES (E.G. COSTS ASSOCIATED WITH ENTERING). YOU FURTHER WAIVE ALL RIGHTS TO HAVE DAMAGES MULTIPLIED OR INCREASED.
